

## REGIONAL AND PROVINCIAL ONE ACT FESTIVAL RULES

- 1. Entries shall be one-act plays. No adaptations or excerpts will be accepted. However, if the author has given written approval for the presentation of an adaptation that adaptation will be allowed to compete.
- 2. All plays must have a running time of at least ten (10) minutes and not more than sixty (60) minutes in length.
- 3. Setup time for each play shall be limited to a maximum of ten (10) minutes; strike time shall be a maximum of five (5) minutes. Please leave the stage clean for the next performers.
- 4. **Both Cast and crew** must be comprised predominantly of adults. The plays may come from amateur theatre troupes, higher educational institutions or any other community group. No member of any Professional Performing Arts Union may participate in any capacity with any ADFA Festival productions.
- 5. Each performing group will pay an entry fee, \$25 of which will make them a member of ADFA. Entrants must sign registration forms stating that they have read and understood the festival rules. In addition, each Region may charge \$25 for entry into the Regional Festival.
- 6. Groups entering the Regional Festival and the selected entries in the Provincial Festival must provide a clean copy of the script for the adjudicators at <u>least two weeks</u> before the Festivals. (Photocopies of published works are not permitted. New works must not have notes or alterations written on the script.)
- 7. The participants in a play entering any festival are responsible for supplying and transporting to and from the festival any set, furniture, properties, etc.
- 8. Please have both a stage manager and a technical director so that if your play is chosen for the Provincials you will have the requisite technical people available.
- 9. A New Work\* is defined by ADFA as a play which has not been performed as a fully staged production prior to 30 days before the Regional Festival to which it has been registered nor has it ever been adjudicated in any form.
